YES	DSLs have WRAP training provided by Stockport Safeguarding Board or complete online training as advised by Stockport Safeguarding. Julia Storey from Stockport Safeguarding Children Partnership is the single point of contact for education in Stockport; she can be contacted for support and guidance or if schools need to make a referral to Channel.
Do staff have relevant training?	YES	DSLs have WRAP training provided by Stockport Safeguarding Children Partnership or complete online training as advised by Stockport Safeguarding. All teaching staff and support staff who have considerable contact with pupils complete Prevent online training as advised by Stockport Safeguarding.

Do pupils have a process to voice their concerns?	YES	Discussion with DSL or pastoral staff (or any member of staff who they feel comfortable speaking to). Pupil concerns to be referred by staff to relevant DSL. Pupils can also email DSL or pastoral staff or, in the Senior School, can use the anonymous Whisper Report an Issue button on Frog.
Are there opportunities for students to be taught about radicalisation and extremism?	YES	Broad and balanced academic curriculum. Pastoral curriculum: Life Studies/PSHE lessons, assemblies and form periods.
Are all Junior School faith assemblies led by staff?	NO	All faith assemblies are led by adults but these may be visiting speakers from the local area.
Are all Senior School faith assemblies led by staff?	NO	Christian assemblies are led by staff or visiting speakers. The other faith

		assemblies (Muslim, Hindu, Sikh and Jewish) are led by pupils.
Are Senior School faith assemblies that are led by pupils (Muslim, Hindu, Sikh and Jewish) attended by staff?	YES	The Chaplain trains the pupils who lead these faith assemblies at the start of the year and arranges review meetings during the year. There is a member of staff on duty at each of these assemblies. These staff refer matters to the DSL if they have any concerns.
Are Senior School Friday Muslim prayers supervised by staff?	YES	The DSL or Chaplain supervises these by sitting in the allocated room.
Is the fortnightly Senior School Christian Club supervised by staff?	YES	These staff refer matters to the DSL if they have any concerns.

An annual review of any cases will take place to identify trends etc. so that the school can be proactive and amend procedures as required.</p> <p>The DSLs will report to the Governing Body annually regarding cases, trends and recommendations following the review.</p> <p>The academic and pastoral curriculum gives the pupils appropriate knowledge of the issues associated with radicalisation and extremism. The curriculum is regularly reviewed.</p> <p>Faith assemblies and Friday Muslim prayers are supervised.</p> <p>There is a visiting speaker protocol in place.</p>
